INVITATION TO APPLICANTS

From 2018 to 2050, the number of People with Dementia will increase from 3.3 to 8.5 million in North West Europe. Because more people will live longer at home in the future, they will also need additional support-products. However, studies show that People with Dementia and their support network do not always know about or trust products that are available.

The Certification-D project will support small to medium sized companies in developing innovative and reliable technological products tailored to the needs of people with dementia living at home. The project:

SIGN-UP FORM selection criteria

Your company needs to meet the following criteria **to be eligible to be invited on an interview**. These criteria will be asked in the sign-up form.

Dimension

Your company should be Small or Medium size as stated by EU Commission

Location

Your company should be located in the North-West Europe area.

Product

Self-evaluation of the TRL (Technology Readiness Level) based on the EU Commission criteria. Products are eligible only from TRL6 to TRL8, but companies can participate to the events and subscribe to the newsletter to be included in further steps of the project.

INTERVIEW DISCUSSION TOPICS selection criteria

The selection to determine which companies are chosen for testing, will be based on the following criteria. These will be topics of discussion during the interview.

- Maturity and suitability of the company
- Relevance and target group fit of the product offering
- Innovative value and uptake potential
- Quality of the proposal and viability to implement
- Added value of support Living Lab
- Product feasibility
